What is likely to capture the attention of most who viewed the coverage given on the USA television networks and social media platforms, is the fact that it was not the employer who recognized the contribution and value of the employee, but instead, his work colleagues. The tokens which his colleagues shared with him that included a movie ticket and other small items, must be the treasures of his life. It has nothing to do with the value of these items, but more so with the recognition, appreciation, respect and high regard that his colleagues have for him.

From what was transmitted on the television networks and social media platforms, this experience was a most humbling one for the employee. The response from people across the world to a Gofundme social media page set up by his daughter as a fundraiser for her father, amassed approximately US \$170,000.
